SUMMARY OF CONDITIONS: This inclusion is subject to the simultaneous approval of the dissolution of the Wheat Ridge Fire Protection District pursuant to the terms and conditions of the Intergovernmental Services and Pre-Inclusion/Dissolution Agreement dated March 24, 2016, between the West Metro Fire Protection District and the Wheat Ridge Fire Protection District, including that Wheat Ridge Fire Protection District taxpayers shall not incur responsibility for West Metro Fire Protection District's current bonded indebtedness.
