WQCD has made tentative determinations in conjunction with EPA that limitations and conditions imposed in these permits implement all applicable statutes and regulations and water-quality standards. Written comments or written requests for a public meeting on the tentative determination are to be submitted to WQCD by March 19, 2012. Also, written comments must be received by this date from any person who believes the proposed actions have the potential to cause material injury to a water right.
