**ADDITIONAL NAMED MEMBER - DESIGNATED SUBDISTRICT**

This endorsement modifies coverage provided under the following:

**PUBLIC ENTITY LIABILITY COVERAGE FORM**

**Section I – Coverage Agreements** is amended to include as an Additional Named **Member** any Subdistrict of the **Named Member** created pursuant to and for the purposes set forth in C.R.S. § 32-1-1101(1)(f), and listed on the **Named Member’s** Declarations. Such Subdistrict is an Additional **Named Member** with respect to liability for those sums which the **Member** shall be legally obligated to pay as damages for “bodily injury”, “personal injury”, “property damage”, or “wrongful act(s)” caused by the **Member’s** acts or omissions, or the acts or omissions of those acting on its behalf, in the performance of authorized operations; all acting within the scope of their employment or duties whether arising out of a governmental or proprietary function.

A Subdistrict’s status as an Additional **Named Member** under this Endorsement ends when the Subdistrict no longer exists as a Subdistrict under C.R.S. § 32-1-1101(1)(f).

In order to be eligible as a Subdistrict, the **Named Member** must have created the Subdistrict pursuant to C.R.S. § 32-1-1101(1)(f), which allows the board of a special district to divide the district into one or more areas consistent with the services, facilities and programs to be furnished in such areas. The Subdistrict shall be an independent quasi-municipal corporation that possesses all of the rights, privileges, and immunities of the **Named Member**. The Subdistrict shall be subject to the service plan of the **Named Member**, is required to comply with the Special District Act, C.R.S. §§ 32-1-101 to 32-1-1807, and shall meet all eligibility requirement of the Special District Act.

Coverage afforded a Subdistrict is subject to all terms, conditions, exclusion, requirements, and provisions of the Coverage Document.

Active Special Districts with the same Board of Directors are allowed to add additional first Named Member districts for \$50.00 per named entity; in such case, shared limits for all entities under a single coverage form apply.
