Title 32, Article 1 Special District Notice of Return to Active Status

The District shall be in compliance with the exempted requirements specified under 32-1-104(5) C.R.S. within ninety days of delivery of this notice.

- the Board of County Commissioners and the City Council/Town Board of each county and municipality that approved the District's service plan pursuant to section 32-1-204 or 32-1-204.5 C.R.S.;
- the Treasurer, Assessor, and the ~~Clark and Recorder~~ of the county(ies) in which the District is located;
- the district court having jurisdiction over the formation of the special district;
- the Office of the State Auditor; and
- the Division of Local Government.

Declaring Return to Active Status

WHEREAS, The Canyons Metropolitan District No. 1 (the "District") is a quasi-municipal corporation and political subdivision of the State of Colorado and is duly organized and existing as a special district pursuant to §§ 32-1-101, *et seq.*, C.R.S.; and

WHEREAS, pursuant to § 32-1-104(3)(a), C.R.S., the Board of Directors of the District elected to become inactive under said statutory section; and

WHEREAS, pursuant to § 32-1-104(3)(b), C.R.S., the Board of Directors has now determined that the District shall return to active status.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE DISTRICT AS FOLLOWS:

1. RETURN TO ACTIVE STATUS. The Board of Directors hereby declares that the District shall be deemed reactivated pursuant to §32-1-104(3)(b), C.R.S. effective immediately upon adoption of this Resolution. The Board hereby directs legal counsel to issue such notices and take such other steps on behalf of the District as may be necessary in connection with this declaration pursuant to § 32-1-104, C.R.S.
