

Shall Roxborough Village Metropolitan District be required to provide, without charge and in perpetuity, landscape maintenance and snow removal services on property owned by any homeowners' association within the District's boundaries that requests it, notwithstanding that such services shall constitute multiple fiscal year obligations that will be paid from the District's ad valorem property taxes that it uniformly assesses and collects within its boundaries; provided that:

- a. The District shall not be responsible for maintaining drainage ways, drainage facilities, detention ponds, or other drainage improvements located within any property owned by a homeowners' association; and,
- b. The District shall only maintain a playground owned by a homeowners' association if it is code compliant and in good repair at the time the District is asked to assume maintenance; and,
- c. If the homeowners' association adds any improvements or alterations the District has not authorized, the District has no obligation to maintain that improvement or alteration; and,
- d. To the extent reasonably practicable, the District's board of directors shall strive to provide the same types and levels of landscape maintenance and snow removal services for all property owned by the District and all property owned by a homeowners' association within the District's boundaries that has requested such services.
