- <u>Section 3</u>. The Town finds that the Director candidates, Jill Gibbens and Stacey Hedrington, are duly qualified and willing candidates to be appointed to the Board of the District.
- Section 4. The Town finds that there are no other duly qualified and willing candidates to be appointed to the Board of the District.
