RESOLUTION OF THE BOARD OF DIRECTORS OF MERIDIAN VILLAGE METROPOLITAN DISTRICT NO. 4 RELATING TO INACTIVE STATUS

WHEREAS, pursuant to Section 32-1-104(3)(a), C.R.S., the Board of Directors of the Meridian Village Metropolitan District No. 4 (the "District") may describe and affirm the District's qualifications for the inactive status of the District; and

WHEREAS, pursuant to Section 32-1-103(9.3), C.R.S., the Board of Directors describes and affirms

- a. that the District is in a predevelopment stage
- b. that the District has no residents within its boundaries;
- c. that the District has no business or commercial ventures or facilities within its boundaries;
- d. that the District has not issued any general obligation or revenue;
- e. that the District has no financial obligations outstanding or contracts in effect that require performance by the District during the time the District is inactive;
- f. that the District has not imposed a mill levy for tax collection in fiscal year 2010;
- g. that the District anticipates no receipt of revenue and has no planned expenditures, except for statutory compliance in fiscal year 2014; and
- h. that the District has no operation or maintenance responsibility for any facilities.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Directors of the Meridian Village Metropolitan District No. 4 (the "Board"), Douglas County, Colorado:

That the notice of inactive status be prepared and filed via certified mail return receipt requested, except where electronic filing is required, with the Board of County Commissioners of Douglas County, the Treasurer, Assessor, and the Clerk and Recorder in Douglas County, the District Court in Douglas County, the office of the Colorado State Auditor, and the office of the Colorado Division of Local Government.

That pursuant to Section 32-1-104(4), C.R.S., the notice of continued inactive status be filed in that manner stated with the office of the Colorado State Auditor and the Division of Local Government on or before December 15 of each year until the Board deems by resolution to return to active status.

That pursuant to Section 32-1-104(4), C.R.S., the District while on inactive status shall not issue any debt, impose a mill levy, or conduct any other official business other than to conduct elections and to undertake procedures necessary to implement the District's intention to return to active status.

That pursuant to Section 32-1-104(5), C.R.S., the District while on inactive status is exempt from compliance with the provisions of Sections 32-1-104(2), 32-1-306, 32-1-809, 32-1-903, Parts 1, 2, and 6 of Article 1 of Title 29, C.R.S. and Part 1 of Article 1 and Part 1 of Article 5 of Title 39, C.R.S.
