

**RESOLUTION NO. 015-034**

**THE BOARD OF COUNTY COMMISSIONERS  
OF THE COUNTY OF DOUGLAS, COLORADO**

**AMENDMENT TO A RESOLUTION EXTENDING THE TEMPORARY ROAD  
CLOSURE OF SURREY DRIVE BETWEEN STIRRUP LANE AND S. HAVANA  
STREET**

**WHEREAS**, Douglas County Engineering Division is requesting an amendment to Resolution No. R-015-025 to extend the time for the temporary road closure for Surrey Drive between Stirrup Lane and S. Havana Street to allow for the emergency replacement of the existing drainage crossing for a tributary to Happy Canyon Creek; and

**WHEREAS**, Surrey Drive is a County-maintained roadway; and

**WHEREAS**, the Board of County Commissioners (the "Board") has the authority to temporarily prohibit the operation of vehicles upon roads within its jurisdiction, pursuant to sections 42-4-106(1) and (6), C.R.S.; and

**WHEREAS**, the temporary road closure of Surrey Drive will be needed beginning on January 2, 2015 through March 31, 2015, extending the current Resolution from March 2, 2015 to the end of March; and

**WHEREAS**, the Douglas County Engineering Division will prepare a detour – signage plan extending the closure of Surrey Drive, now, therefore,

**BE IT RESOLVED**, by the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, that the approval of this Amendment to Resolution R-015-025 extending the temporary road closure of Surrey Drive between Stirrup Lane and S. Havana Street from March 2, 2015 to March 31, 2015 is hereby approved; and

**BE IT FURTHER RESOLVED** that the detour signs, warning signs, and barricades now at designated locations, as shown on the attached Exhibit A, shall remain for the extended period of construction for the temporary closure authorized herein; and

**BE IT FURTHER RESOLVED** that such warning signs and barricades shall be removed and such road shall be reopened upon expiration of the extended temporary closure approved herein, or at such earlier time as determined by Douglas County Engineering Division.

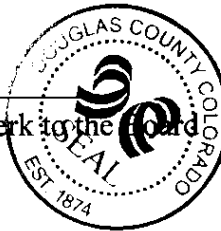
