## A RESOLUTION OF THE BOARD OF DIRECTORS CALLING AN ELECTION FOR THE RURAL WATER AUTHORITY OF DOUGLAS COUNTY

WHEREAS, the terms of office of Directors Giclas, Love, Dearborn, LaPorte, Wilson, Beane and Gager, have been vacated or shall expire after their successors are elected at the regular election to be held on May 2, 2015 ("Election"), and take office; and

WHEREAS, in accordance with the provisions of the Special District Act ("Act") and the Uniform Election Code ("Code"), the Election must be conducted to elect these seven (7) Directors to serve for a term of two or four years.

NOW, THEREFORE, be it resolved by the Board of Directors of the District, that:

- 1. <u>Date and Time of Election</u>. The regular election of the eligible electors of the District shall be held on May 2, 2015, between the hours of 9:00 A.M. and 12:00 P.M. pursuant to and in accordance with the Act, Code, Autority Bylaws and Election Rules and other applicable laws. At that time, three (3) Directors will be elected to serve for a term of two (2) years, and four (4) Directors will be elected to serve for a term of four (4) years.
- 2. <u>Precinct</u>. The District shall be divided into 1 (one) election precinct for the convenience of the eligible electors of the District.
- 3. <u>Conduct of Election Code</u>. The Election shall be conducted as a polling place election in accordance with all relevant provisions of the Code. The Secretary and/or Designated Election Official shall notify the Secretary of State of the District's decision and submit a plan for conducting the mail ballot election, which may be based on the standard plan adopted by the Secretary of State. There shall be no election precinct or polling place. All ballots shall be returned to the Designated Election Official's office after being processed at the Election Site.
- 4. <u>Designated Election Official</u>. Sarah E. E. Shepherd shall be the Designated Election Official and is hereby authorized and directed to proceed with any action necessary or appropriate to effectuate the provisions of this Resolution and of the Act, Code, or other applicable laws. Among other matters, the Designated Election Official shall appoint election judges as necessary, arrange for the required notices of election (either by mail or publication) and printing of ballots, and direct that all other appropriate actions be accomplished.
- 5. <u>Self-Nomination and Acceptance Forms</u>. Self-nomination and acceptance forms are available at the Designated Election Official's office located at 4051 Bryant Street, Denver, CO 80211, by phone at 303-482-1002, or by email at sees@ccrider.us. All Director candidates must file self-nomination and acceptance forms with the Designated Election Official no later than 5:00 P.M. on February

- 24, 2015, and all Write-in Candidates or Small Water Service Providers must file affadavits to be a write-in candidate or self-nomination and acceptance form to be a Small Water Service Provider Director no later than 5:00 P.M. on April 1, 2015.
- 6. <u>Cancellation of Election</u>. If the only matter before the electors is the election of Directors of the District and if, at 5:00 P.M. on April 1, 2015, there are not more candidates than offices to be filled at the Election, including candidates' timely filing Affidavits of Intent, the Designated Election Official shall cancel the Election and by Resolution declare the candidates elected. Notice of such cancellation shall be published and posted in accordance with law.
- 7. <u>Severability</u>. If any part or provision of this Resolution is adjusted to be unenforceable or invalid, such judgment shall not affect, impair or invalidate the remaining provisions of this Resolution, it being the Board's intention that the various provisions hereof are severable.
- 8. Repealer. All acts, orders, and resolutions, or parts thereof, of the Board which are inconsistent or in conflict with the Resolution are hereby repealed to the extent only of such inconsistency of conflict.
- 9. <u>Effective Date</u>. The provisions of this Resolution shall take effect January 28, 2015.
