RESOLUTION SUMMARIZING REVENUES AND EXPENDITURES AND ADOPTING A BUDGET FOR THE DOUGLAS COUNTY LOCAL IMPROVEMENT DISTRICT NO. 07-01 – LINCOLN STATION FOR THE FISCAL YEAR BEGINNING ON THE FIRST DAY OF JANUARY 2016 AND ENDING THE LAST DAY OF DECEMBER 2016.

WHEREAS, whatever increases may have been made in the expenditures, like increases were added to the revenues or planned to be expended from reserves/carryover funds so that the Douglas County Local Improvement District No.07-01 - Lincoln Station budget remains in balance, as required by law; now, therefore,
