District Policy – In addition to the other fees set forth in the Official Custodian's Rules (available upon request), in accordance with Section 24-72-205(6), C.R.S., the Official Custodian or his or her designee may charge a nominal research and retrieval fee of \$30.00 per hour, or such other maximum hourly fee as may be adjusted from time to time pursuant to Section 24-72-205(6)(b), C.R.S., for time spent by the District's directors, employees, agents and consultants researching, retrieving, gathering, collecting, compiling, preparing, redacting, and/or otherwise manipulating records in order to respond to a request for Public Records. Provided, however, that such research and retrieval fee may not be imposed for the first hour of time expense in connection with such research and retrieval activities related to a request for Public Records, but may be imposed for each subsequent hour.
