Specifically, the Board intends to consider adoption of a Resolution authorizing the issuance of the District's Limited Tax General Obligation Bonds, Series 2022A and Subordinate Limited Tax General Obligation Bonds, Series 2022B(3) (the "Bonds"), in a maximum aggregate principal amount not to exceed \$6,441,000, for the purpose of financing or reimbursing the costs of certain public improvements, funding the reserve fund, funding capitalized interest and paying the costs of issuance of the Bonds.

Also at this meeting, the Board also expects to authorize the execution of all related documents, instruments and certificates in connection therewith, ratify prior actions, authorize incidental actions, repeal prior inconsistent actions, repeal the resolution adopted on July 8, 2022, and take up such other business as may come before the Board.
