


THIS MATTER comes before the Court upon the Motion of the Parker Fire Protection District ("District") to Include Property, Change the District's Name to South Metro Fire Rescue Fire Protection District, Expand the Board of Directors from Five (5) Members to Seven (7) Members, Set the Boundaries of Director Districts, and Set Initial Terms of Office for Each Director District, and the Court having reviewed the matter and being fully advised in the premises,

1. ORDERS that all real property previously located within the boundaries of South Metro Fire Rescue (the "South Metro Property") be included within the Parker Fire Protection District; and
2. FURTHER ORDERS that the District's name is changed to "South Metro Fire Rescue Fire Protection District" and that the District is authorized to register and use the trade names "South Metro Fire Rescue" and "SMFR;" and

3. FURTHER ORDERS that the District's Board of Directors shall be expanded to seven (7) members elected or appointed from Director districts; and

4. FURTHER ORDERS that Director Districts boundaries are hereby established as depicted below:

5. FURTHER ORDERS that to maintain the appropriate staggering of four-year terms, the initial terms of office shall be as follows:
