**Re: Proposed Reata Ridge Village Metropolitan District No. 1
Registered Elector Lists for the May 3, 2016 Election**

Dear Clerk and Recorder:

In accordance with § 1-13.5-111, C.R.S., the proposed Reata Ridge Village Metropolitan District No. 1 (“District”) is holding an organizational election on May 3, 2016. Eligible electors for Title 32 special districts include all individuals who are residents of the special district and who are registered to vote in Colorado pursuant to the Uniform Election Code of 1992, Articles 1 to 13 of Title 1, C.R.S.

In accordance with statute, as the Designated Election Official for the District, I hereby request the following lists:

1. A list of all UOCAVA “covered voters,” as such term is defined in § 1-8.3-102(2), C.R.S. Please provide the UOCAVA list as soon as possible and no later than March 14, 2016 in order to meet the March 18, 2016, UOCAVA ballot mailing deadline.
2. Pursuant to §§ 1-13.5-203(1)-(3) and 1-13.5-1105(2)(a), C.R.S., and in order to accommodate an April 1, 2016 requirement to mail TABOR notices, please provide an initial list of the registered electors in the District no later March 28, 2016. The initial list is required to contain the names and addresses of all registered electors residing within the District at the close of business on the fortieth (40th) day preceding the election, or as of March 24, 2016.
3. Pursuant to §§ 1-13.5-203(1)-(3) and 1-13.5-1105(2)(b), C.R.S., please provide a supplemental list of the registered electors in the District no later than the twentieth (20th) day prior to the election (April 13, 2016). The supplemental list is required to contain the names and addresses of all registered electors residing within the District at the close of business on the twenty-second (22nd) day preceding the election, or as of April 11, 2016. If the supplemental list is not different from the initial list, please confirm for us that there have been no changes.

A map and legal description of the District's boundaries are enclosed for your reference.
