BE IT RESOLVED, by the BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO, hereby authorizes the approval of the temporary road closure of Northridge Road between Jack Rabbit Place and Prairie Ridge Road for five (5) days between January 11, 2017 and February 28, 2017, when weather allows completion of the Project.

BE IT FURTHER RESOLOVED that a signed detour and approved warning signs and barricades shall be erected at designated locations, as shown on the attached Exhibit A, prior to the temporary closure authorized herein.

BE IT FURTHER RESOLVED that such warning signs and barricades shall be removed and such road shall be reopened upon expiration of the temporary closure approved herein, or at such earlier time as determined by Douglas County Engineering Division.

DESCRIPTION:

Resolution for Temporary Road Closure for Northridge Road between Jack Rabbit Place and Prairie Ridge Road, associated with the Northridge Road Out Fall Repair Project, Douglas County Project Number DV 2016 – 109.

SUMMARY:

Staff is requesting a temporary closure of Northridge Road between Jack Rabbit Place and Prairie Ridge Road in Highlands Ranch for repair of the existing drainage system. The Project will repair 284 feet of failing 30" corrugated metal pipe within Northridge Road.

Staff is requesting a maximum of 5 days temporary road closure to complete the Project. Once final dates can be set for the closure the following actions will be taken: a detour route will be signed and in place during the closure; variable message signs will be placed in advance of the closure; public notices will be sent to the surrounding neighborhood, HRMD and HRCA prior to the closure; and the school district and emergency services will be notified prior to the closure.

The closure dates will be set when weather allows an adequate window of days to complete the work.
