

**PUBLIC NOTICE OF A SPECIAL MEETING OF THE
BOARDS OF DIRECTORS OF
RAMPART RANGE METROPOLITAN DISTRICT NOS. 1, 2 AND 7**

NOTICE IS HEREBY GIVEN that the Boards of Directors of the Rampart Range Metropolitan District Nos. 1, 2 and 7 ("Boards"), City of Lone Tree, Douglas County, Colorado, will meet in special session on Thursday, October 19, 2017, at the hour of 9:30 a.m., at the offices of Kutak Rock LLP, 1801 California Street, Suite 3100, Denver, Colorado 80202.

At this meeting, it is anticipated that the Board of Directors of Rampart Range Metropolitan District No. 1 ("RRMD1") will make a final determination to issue or refund general obligation indebtedness. Specifically, RRMD1 intends to consider ratifying adoption of a resolution authorizing the issuance of the RRMD1's Limited Tax Supported and Special Revenue Refunding and Improvement Bonds, Series 2017 in the approximate aggregate principal amount of \$190,000,000.00 ("Series 2017 Bonds"). The resolution will also authorize the execution of an Indenture of Trust, one or more bond purchase agreements, a Third Amended and Restated Capital Pledge Agreement, a First Amended and Restated PIF Collecting Agent Agreement, and other related documents; ratifying and confirming the execution of certain documents; making determinations and findings as to other matters related to such transaction; authorizing incidental actions; and repealing prior inconsistent actions. It is also anticipated that at such meeting the Boards of Directors of Rampart Range Metropolitan District Nos. 2 and 7 ("RRMD2 and 7") will make a final determination with respect to the issuance of general obligation debt consisting of a Third Amended and Restated Capital Pledge Agreement between Rampart Range Metropolitan District Nos. 1, 2, 7 and will acknowledge RRMD1's issuance of the Series 2017 Bonds, which are payable by certain revenues of RRMD2 and 7 in accordance with such Third Amended and Restated Capital Pledge Agreement.

The Boards will also take up such other business as may be before the Boards. The meeting is open to the public.

Pursuant to the provisions of the Supplemental Public Securities Act, one or more members of the Boards may participate in this meeting and may vote on the foregoing matters through the use of a conference telephone or other telecommunications device.
