**THE BOARD OF COUNTY COMMISSIONERS  
OF THE COUNTY OF DOUGLAS, COLORADO**

**A RESOLUTION APPROVING THE TEMPORARY ROAD CLOSURE OF DANIELS  
PARK ROAD BETWEEN CASTLE PINES PARKWAY AND GRIGGS ROAD**

**WHEREAS**, Douglas County Engineering Division is requesting a temporary road closure for Daniels Park Road between Castle Pines Parkway and Griggs Road. The closure will allow for the completion of the final phase of the Daniels Park Phase 2 Improvements Project; and

**WHEREAS**, Daniels Park Road is a County-maintained roadway; and

**WHEREAS**, the Board of County Commissioners (the "Board") has the authority to temporarily close any highway or portion thereof within its jurisdiction to all vehicular traffic for the purpose of road and construction maintenance, pursuant to section 42-4-106(6), C.R.S.; and

**WHEREAS**, the temporary road closure of Daniels Park Road will be needed for a maximum of 101 days in calendar year 2018, between on March 21, 2018 and June 30, 2018; and

**WHEREAS**, the Douglas County Engineering Division has prepared a detour – signage plan for the closure of Daniels Park Road; and

**WHEREAS**, the Board finds that the temporary closure of Daniels Park Road between Castle Pines Parkway and Griggs Road and rerouting of traffic in accordance with the foregoing detour plan is necessary for traffic safety and for the protection of work crews and road equipment; now, therefore,

**BE IT RESOLVED**, by the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, hereby authorizes the approval of the temporary road closure of Daniels Park Road between Castle Pines Parkway and Griggs Road for a maximum of 101 days in calendar year 2018, between on March 21, 2018 and June 30, 2018 for the purpose of road construction and maintenance.

**BE IT FURTHER RESOLOVED** that a signed detour route with approved warning signs and barricades shall be erected at designated locations, as shown on the attached Exhibit A, prior to the temporary closure authorized herein.

**BE IT FURTHER RESOLVED** that such warning signs and barricades shall be removed and such road shall be reopened upon expiration of the temporary closure approved herein, or at such earlier time as determined by Douglas County Engineering Division.

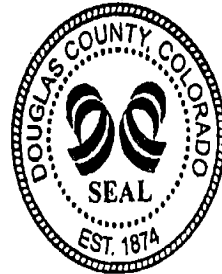
