**RESOLUTION CONCERNING A VACANCY IN THE OFFICE OF DOUGLAS  
COUNTY TREASURER.**

**WHEREAS**, on April 9, 2018 the Douglas County Republican Party appointed then Douglas County Treasurer Diane A. Holbert to fill a vacancy in Douglas County Commissioner District 1 pursuant to Colo. Constitution Article XIV Section 9; and

**WHEREAS**, Diane A. Holbert resigned from her position as Douglas County Treasurer on that date in order to accept the appointment as County Commissioner, creating a vacancy in the office of Douglas County Treasurer; and

**WHEREAS**, Peter Boyd, having been appointed as Chief Deputy Treasurer by Diane Holbert prior to her resignation from the office of Treasurer, is currently serving as and will continue to serve as Douglas County Treasurer pursuant to C.R.S. § 30-10-704 until such vacancy is filled; and

**WHEREAS**, the Board of County Commissioners (Board) is authorized to fill such vacancy pursuant to C.R.S. § 30-10-705;

**WHEREAS**, there are two individuals running for the Republican nomination for the Douglas County Treasurer position in the 2018 General election and both are scheduled to appear on the Primary Ballot in June 2018; and

**WHEREAS**, due to the timing of the vacancy and the timing of the regular election cycle, the Board does not wish to interfere with or give the appearance of interfering with the election or process for the 2018 election for the Office of the Treasurer nor does the Board want to unnecessarily disrupt the regular business of the office of the Treasurer by making any appointment that could potentially be short term; and

**WHEREAS**, the Board believes that Peter Boyd will continue to run the business of the Office of the Treasurer in its' historically professional manner, without disruption and without unnecessary change and such service would be in the best interests of Douglas County residents in the short term; and

**WHEREAS**, the Board is willing to revisit this issue after completion of the primary election and completion of the Board of Canvass certification of such election result; now, therefore,

**BE IT RESOLVED, BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS**, that Peter Boyd, acting in his capacity of Chief Deputy Treasurer will continue to serve in the capacity of Douglas County Treasurer until such time as the Board fills such vacancy in the Office of Douglas County Treasurer or until the next Douglas County Treasurer is duly elected and sworn in to office, whichever occurs first.


