**THE BOARD OF COUNTY COMMISSIONERS
OF THE COUNTY OF DOUGLAS, COLORADO**

**A RESOLUTION APPROVING THE TEMPORARY ROAD CLOSURE OF SOUTH
COUNTY HIGHWAY 67 (SUGAR CREEK ROAD) AT THE INTERSECTION OF SOUTH
PLATTE RIVER ROAD (COUNTY ROAD 97) TO THE WYE INTERSECTION OF
SOUTH COUNTY HIGHWAY 67 (SUGAR CREEK ROAD) AND PINE CREEK ROAD**

WHEREAS, Douglas County Engineering Division is requesting a temporary road closure of South County Highway 67(Sugar Creek Road) at the intersection of South Platte River Road (County Road 97) to the wye intersection of South County Highway 67(Sugar Creek Road) and Pine Creek Road for the construction of environmental mitigation related to the Chatfield Storage Reallocation project; and

WHEREAS, South County Highway 67 is a County-maintained roadway; and

WHEREAS, the Board of County Commissioners (the "Board") has the authority to temporarily close any highway or portion thereof within its jurisdiction to all vehicular traffic for the purpose of road and construction maintenance, pursuant to section 42-4-106(6), C.R.S.; and

WHEREAS, the temporary road closure of South County Highway 67 (Sugar Creek Road) will be needed for approximately three months between May 29, 2018 and August 28, 2018; and

WHEREAS, the Chatfield Reservoir Mitigation Company has contracted with Ames Construction, Inc. and their Contractor has prepared detour – signage plan to be finalized by a Certified Traffic Control Supervisor for the closure of South County Highway 67 (Sugar Creek Road); and

WHEREAS, the Board finds that the temporary closure of South County Highway 67 (Sugar Creek Road) at the intersection of South Platte River Road (County Road 97) to the wye intersection of South County Highway 67 (Sugar Creek Road) and Pine Creek Road and rerouting of traffic in accordance with the foregoing detour plan is necessary for traffic safety and for the protection of work crews and road equipment; now, therefore,

BE IT RESOLVED, by the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, hereby authorizes the approval of the Temporary Road Closure of South County Highway 67 (Sugar Creek Road) at the intersection of

South Platte River Road (County Road 97) to the wye intersection of South County Highway 67(Sugar Creek Road) and Pine Creek Road for approximately three months between May 29, 2018 and August 28, 2018 for the purpose of road construction and maintenance.

BE IT FURTHER RESOLVED that a signed detour route with approved warning signs and barricades shall be erected at designated locations, as shown on the attached Exhibit A and finalized traffic Control Plan completed by a Certified Traffic Control Supervisor to include advance turn around for trailered vehicles; and the public, emergency access provisions through the closure; United States Forrest Service coordination; the school district and all emergency services will be notified prior to the temporary closure authorized herein.

BE IT FURTHER RESOLVED that such warning signs and barricades shall be removed and such road shall be reopened upon expiration of the temporary closure approved herein, or at such earlier time as determined by Douglas County Engineering Division.
