**RESOLUTION AUTHORIZING THE TEMPORARY CLOSURE OF DOUGLAS
COUNTY COLORADO MOTOR VEHICLE OFFICES DURING BUSINESS HOURS
FROM 8:00 AM TO 5:00 PM, WEDNESDAY, AUGUST 1, 2018, AND RE-OPENING
MONDAY, AUGUST 6, 2018: AND THE TEMPORARY CLOSURE OF DOUGLAS
COUNTY COLORADO DRIVER LICENSE OFFICES DURING BUSINESS HOURS
FROM 8:00 AM TO 5:00 PM, THURSDAY, AUGUST 2, 2018, AND RE-OPENING
MONDAY, AUGUST 6, 2018.**

WHEREAS, pursuant to section 30-10-109, C.R.S., the Board of County Commissioners ("Board") is empowered, by resolution, to set the days and hours that county offices shall be open for the transaction of county business; and

WHEREAS, the County Clerk and Recorder has notified the Board that due to technology upgrades to the state-wide motor vehicle and driver license computer system, all motor vehicle and driver license offices located in Douglas County need to be closed in order to perform the technology upgrades; and

WHEREAS, the Board has determined that it is in the best interest of the County to temporarily close the Douglas County motor vehicle offices, during business hours from 8:00 am to 5:00 pm, Wednesday, August 1, 2018, and re-opening Monday, August 6, 2018, and that it is in the best interest of the County to temporarily close the Douglas County driver license offices during business hours, from 8:00 am to 5:00 pm, Thursday, August 2, 2018 and re-opening on Monday, August 6, 2018, in order to allow for the upgrades to the state-wide motor vehicle and driver license computer system; now, therefore,

BE IT RESOLVED, BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO, that the Douglas County motor vehicle offices shall be temporarily closed during business hours from 8:00 am to 5:00 pm, August 1, 2018, and that the Douglas County driver license offices shall be temporarily closed during business hours from 8:00 am to 5:00 pm, August 2, 2018, and that said offices shall reopen August 6, 2018.
