PROPERTY TAXES AS BEING UNCOLLECTIBLE.**


*WHEREAS*, pursuant to section 39-10-114(2), C.R.S., the Douglas County Chief Deputy Treasurer has determined that those taxes levied on real, personal, and state assessed property, as set forth in **Exhibit A**, attached hereto and incorporated herein, are uncollectible and should be cancelled by the Board of County Commissioners; and

*WHEREAS*, the total uncollectible amount of taxes is \$35,643.80.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, COLORADO**, that pursuant to section 39-10-114(2), C.R.S., those unpaid real, personal, and state assessed property taxes as set forth in **Exhibit A**, have been determined to be uncollectible as the Chief Deputy Treasurer has exhausted every means to collect said taxes, and are therefore cancelled and removed from the Treasurer's tax roll.


