A RESOLUTION REZONING THREE PARCELS OF LAND, TOTALING 132.2 ACRES, LOCATED IN DOUGLAS COUNTY, COLORADO FROM GENERAL INDUSTRIAL, RURAL RESIDENTIAL, AND AGRICULTURAL ONE TO AGRICULTURAL ONE

WHEREAS, Michele Chang as manager of Fox Hill Equestrian Center, LLC, has requested rezoning of certain parcels of land, Project File No. DR2018-006, more particularly described in **Exhibits A, B, and C**, which are attached hereto and incorporated herein, from <u>General Industrial</u>, Rural Residential and Agricultural One to <u>Agricultural One</u> ("Rezoning"); and

WHEREAS, the Planning Commission reviewed and recommended approval of the Rezoning at a public hearing on October 15, 2018; and


