Pursuant to Section 32-1-306, C.R.S., our office is notifying you that the boundaries of the Castle Rock Fire Protection District did change during the year of 2018. A map depicting the general boundaries of the District is attached hereto as **Exhibit A**.

By Ordinance Nos. 2017-017, 2017-020, and 2018-020 of the Town of Castle Rock and subsequent Order entered by the Douglas County District Court on December 12, 2018 and recorded in the records of Douglas County on December 13, 2018 at reception number 2018074525, the properties described in **Exhibit B** attached hereto were excluded from the boundaries of the District.

Furthermore, by Order of the Douglas County District Court entered on December 8, 2018 and recorded in the records of Douglas County on December 10, 2018 at reception no. 2018073922, the property described in said Order (attached hereto as **Exhibit C**) was also excluded from the boundaries of the District.

Please note the map attached as Exhibit A has not been updated to reflect the above-referenced exclusions, as the exclusions would not be easily discernable on the map. Should you have any questions, please do not hesitate to contact our office.


