

**PUBLIC NOTICE OF A REGULAR MEETING OF THE  
BOARDS OF DIRECTORS OF  
RAMPART RANGE METROPOLITAN DISTRICT NOS. 1, 2 AND 7**

NOTICE IS HEREBY GIVEN that the Boards of Directors of the Rampart Range Metropolitan District Nos. 1, 2 and 7 ("Boards"), City of Lone Tree, Douglas County, Colorado, will meet in regular session on Thursday, April 24, 2019, at the hour of 3:00 p.m., at the offices of Coventry Development, 10270 Commonwealth Street, Suite B, Lone Tree, Colorado 80124.

At this meeting, it is anticipated that the Board of Directors of Rampart Range Metropolitan District No. 1 ("RRMD1") will make a final determination to issue or refund special limited revenue indebtedness. Specifically, RRMD1 intends to consider adoption of a resolution authorizing the issuance of the RRMD1's Limited Tax Supported and Special Revenue Note, Series 2019 in the approximate aggregate principal amount of \$10,000,000 ("Series 2019 Note") evidencing RRMD1's payment obligation with respect to a loan to be made to it by Compass Mortgage Corporation, in accordance with a Loan Agreement between RRMD1 and Compass Mortgage Corporation. The resolution will also authorize the execution of such Loan Agreement, and other related documents and certificates; ratifying and confirming the execution of certain documents; making determinations and findings as to other matters related to such transaction; authorizing incidental actions; and repealing prior inconsistent actions. It is also anticipated that at such meeting the Boards of Directors of Rampart Range Metropolitan District Nos. 2 and 7 ("RRMD 2 and 7") will make a final determination with respect to the issuance of general obligation debt by confirming that the 2019 Loan and Series 2019 Note constitute Obligations for which RRMD 2 and 7 are obligated to impose ad valorem property taxes in accordance with a Third Amended and Restated Capital Pledge Agreement between Rampart Range Metropolitan District Nos. 1, 2, 7 and will authorize other related documents and certificates.

The Boards will also take up such other business as may be before the Boards. The meeting is open to the public.

***Pursuant to the provisions of the Supplemental Public Securities Act, one or more members of the Boards may participate in this meeting and may vote on the foregoing matters through the use of a conference telephone or other telecommunications device.***
