WHEREAS, Douglas County desires to comply with the Compliance Schedule of the MS4 Permit by updating the GESC Manual before July 1, 2019; and

WHEREAS, Douglas County Engineering Division has prepared an Amendment to Sections 1, 3, 8, 9, 10 and Appendix J as well as other minor corrections and updates of the GESC Manual.; and

WHEREAS, the Board desires to reflect its approval and adoption of these changes to the GESC Manual; and

BE IT RESOLVED, by the BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO, pursuant to § 30-15-401(11), C.R.S., hereby authorizes the approval and adoption of the amendment to the Douglas County Grading Erosion Sediment Controls Manual (GESC) Manual, attached hereto as Exhibit A and incorporated herein.
