Interested electors of the Districts may inspect the proposed budgets and any amendment to the 2019 budgets, and file any objections to such budgets or any amendment to the 2019 budgets, at any time prior to their final adoption by the Boards.

The November 6, 2019 meeting will be held for the purpose of: i) holding a public hearing on Proposed 2020 Budgets for Districts No. 1 through 5; ii) reviewing and taking action on Resolutions re: Summarizing Expenditures and Revenues for each Fund and Adopting Budgets for 2020 and, if needed, Amended Budgets for 2019, for Districts No. 1 through 4; iii) reviewing and taking action on Resolutions re: Appropriating Sums of Money to the Various Funds for Districts No. 1 through 5; iv) reviewing and taking action on Resolutions re: Levying Property Taxes for Year 2018 for Collection in 2020; v) reviewing and taking action on Certification of Tax Levies, for Districts No. 1 through 5; vi) reviewing and considering acceptance of financial statements; vii) reviewing and taking action on claims; viii) considering renewal of Agreement with Pinnacle Consulting Group, Inc. for Professional Accounting Services for 2020; ix) appointment of officers; x) considering compensation for Directors; xi) reviewing and taking action on Resolutions Regarding Administrative Matters for 2020 for Districts No. 1 through 5; xii) Directors' items, if any; xiv) discussion regarding leases for billboards located on District-owned property; and xv) any other business that may come before the Boards of Directors of the Districts.
