

**RESOLUTION NO. R-020-<sup>042</sup>**

**THE BOARD OF COUNTY COMMISSIONERS  
OF THE COUNTY OF DOUGLAS, COLORADO**

**A RESOLUTION APPROVING THE TEMPORARY ROAD CLOSURE GREENLAND  
ROAD BETWEEN DAHLBURG ROAD AND SH83**

**WHEREAS**, Douglas County Engineering Division is requesting a temporary road closure for Greenland Road between Dahlburg Road and SH83. The closure will allow for the repair of a failing existing drainage culvert under Greenland Road, see Exhibit A for Project location; and

**WHEREAS**, Greenland Road is a County-maintained roadway; and

**WHEREAS**, the Board of County Commissioners (the "Board") has the authority to temporarily prohibit the operation of vehicles upon roads within its jurisdiction, pursuant to sections 42-4-106(1) and (6), C.R.S.; and

**WHEREAS**, the temporary road closure of Greenland Road will be needed for a maximum of 5 days, between on May 20, 2020 and July 1, 2020, when weather allows the completion of the Project on five consecutive days; and

**WHEREAS**, the Douglas County PW Engineering Division will prepare a detour – signage plan prior to the closure of Greenland Road, now, therefore,

**BE IT RESOLVED**, by the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, hereby authorizes the approval of the temporary road closure of Greenland Road between Dahlburg Road and SH83 for five (5) consecutive days between May 20, 2020 and July 1, 2020, when weather allows completion of the Project.

**BE IT FURTHER RESOLVED** that a signed detour route with approved warning signs and barricades shall be erected at designated locations prior to the temporary closure authorized herein.

**BE IT FURTHER RESOLVED** that such warning signs and barricades shall be removed and such road shall be reopened upon expiration of the temporary closure approved herein, or at such earlier time as determined by Douglas County Engineering Division.
