

**RESOLUTION NO. R-020- 066**

**THE BOARD OF COUNTY COMMISSIONERS  
OF THE COUNTY OF DOUGLAS, COLORADO**

**A RESOLUTION APPROVING THE EXTENSION OF A TEMPORARY ROAD  
CLOSURE OF ROXBOROUGH PARK ROAD NORTH OF MOUNTAIN VIEW LANE  
TO THE EXISTING CONNECTION WITH ROXBOROUGH PARK ROAD INTO  
CHATFIELD STATE PARK**

**WHEREAS**, Shea Homes is requesting the extension of a temporary road closure for Roxborough Park Road north of Mountain View Lane to the existing connection with Roxborough Park Road into Chatfield State Park for the construction of the new alignment of Roxborough Park Road; and

**WHEREAS**, Roxborough Park Road is a County-maintained roadway; and

**WHEREAS**, the Board of County Commissioners (the “Board”) has authority to temporarily prohibit the operation of vehicles upon highways within its jurisdiction, pursuant to section 42-4-106(6), C.R.S.; and

**WHEREAS**, the temporary road closure of Roxborough Park Road will expire on July 28<sup>th</sup> and will need to be extended for an additional 45 days, unless otherwise extended by resolution of the Board; and

**WHEREAS**, the Douglas County Engineering Division will approve a signage plan prior to the closure of Roxborough Park Road, now, therefore,

**BE IT RESOLVED**, by the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, that pursuant to section 42-4-106(6), C.R.S., the temporary road closure of Roxborough Park Road north of Mountain View Lane to the existing connection with Roxborough Park Road into the Chatfield State Park will need to be extended for an additional 45 days.

**BE IT FURTHER RESOLVED** that a signage plan shall be submitted and approved by the Douglas County Engineering Division and approved warning signs and barricades shall be erected at designated locations prior to the temporary closure authorized herein.

**BE IT FURTHER RESOLVED** that such warning signs and barricades shall be removed, and such road shall be reopened upon expiration of the temporary closure approved herein, or at

such earlier time as the Board, by subsequent action, directs that the temporary closure be terminated.
