**RESOLUTION PROCLAIMING APPRECIATION FOR EXCEPTIONAL RESPONSE
TO THE CHATRIDGE 2 WILDLAND FIRE.**

WHEREAS, on the 29th of June, 2020 a wildland fire started near the intersection of Highway 85 and Chatridge Court in unincorporated Douglas County; and

WHEREAS, South Metro Fire Rescue and Douglas County Sheriff's Office personnel responded rapidly to suppress the fire and ensure public safety; and

WHEREAS, conditions in the area were extremely hot, dry and windy causing the fire to erupt and grow rapidly towards homes on Chatridge Court and the Backcountry Subdivision; and

WHEREAS, mutual aid resources were requested throughout Douglas County and the metro region to help suppress this dangerous and rapidly growing wildfire; and

WHEREAS, the swift response and actions of the agencies listed directly resulted in suppressing the Chatridge 2 wildland fire to just under 500 acres with no significant property loss or injuries; now, therefore
