A RESOLUTION APPROVING THE TEMPORARY ROAD CLOSURE OF DOUGLAS AVE. WHERE IT INTERSECTS WITH VICTOR STREET AND CLAY STREET WHERE IT INTERSECTS WITH RIO GRANDE AVENUE

WHEREAS, Douglas County Public Works Operations is requesting a temporary road closure at the intersection of Douglas Avenue and Victor Street and Rio Grande Avenue and Clay Street in Sedalia, Colorado, for the installation of a drainage culvert at the intersection of Douglas Avenue and Clay Street; and

WHEREAS, Douglas Avenue and Clay Street are County-maintained roadways; and

WHEREAS, the Board of County Commissioners (the "Board") has authority to temporarily prohibit the operation of vehicles upon highways within its jurisdiction, pursuant to section 42-4-106(6), C.R.S.; and

WHEREAS, the temporary road closure of Douglas Avenue and Clay Street will be needed for ten (10) working days, beginning on November 9, 2020 and estimated to be complete no later than November 20, 2020, unless otherwise extended by resolution of the Board; and

WHEREAS, the Douglas County Public Works Operations Department will approve a signage plan prior to the closure of Douglas Avenue and Clay Street, now, therefore,

BE IT RESOLVED, by the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, that pursuant to section 42-4-106(6), C.R.S., the temporary road closure of Douglas Avenue and Clay Street, beginning on November 9, 2020, for ten (10) working days, is hereby approved.

BE IT FURTHER RESOLVED that a signage plan shall be submitted and approved by the Douglas County Public Works Operations Department, and approved warning signs and barricades shall be erected at designated locations prior to the temporary closure authorized herein.

BE IT FURTHER RESOLVED that such warning signs and barricades shall be removed and such road shall be reopened upon expiration of the temporary closure approved herein, or at such earlier time as the Board, by subsequent action, directs that the temporary closure be terminated.
