**RESOLUTION FOR THE DOUGLAS COUNTY LOCAL DISASTER EMERGENCY
DECLARATION TERMINATION.**

WHEREAS, on March 5, 2020, the Director of the Office of Emergency Management advised the Board of County Commissioners of Douglas County ("the Board") of a disaster (as that term is defined in the Colorado Disaster Emergency Act, Part 7 of Article 33.5 of Title 24, C.R.S.) currently located in Douglas County Colorado which occurred as a result of the COVID-19 infectious disease pandemic; and

WHEREAS, a Local Disaster Emergency Declaration in response to the COVID-19 pandemic was officially declared on March 13, 2020; and

WHEREAS, the Board continued the Disaster Emergency Declaration every 30 days (as that term is defined in the Colorado Disaster Emergency Act, Part 7 of Article 33.5 of Title 24, C.R.S.) until April 20th, 2021; and

WHEREAS, COVID-19 currently continues to improve with regard to public health, the medical system, first responders, and many businesses; and

WHEREAS, the incident and the response and recovery no longer exceed operational resources available to Douglas County Government; and

WHEREAS, the Douglas County Director of the Office of Emergency Management has recommended that Chair of the Douglas County Board of County Commissioners, who is the principal executive officer of Douglas County, to terminate the declaration of the local disaster.

NOW THEREFORE BE IT RESOLVED there is hereby declared the termination of the Local Disaster Emergency that has been in effect since the 13th of March, 2020 for Douglas County, Colorado, and the Chair of the Board of County Commissioners of Douglas County, Colorado declares no need for a disaster emergency declaration to continue.

BE IT FURTHER RESOLVED this disaster emergency declaration termination shall be given prompt and general publicity and shall be filed promptly with the County Clerk and Recorder, and the Colorado Division of Homeland Security and Emergency Management (CDHSEM).
