## THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, COLORADO

RESOLUTION FOR TEMPORARY ROAD CLOSURE FOR INCA ROAD BETWEEN DELAWARE DRIVE AND CHEYENNE DRIVE, ASSOCIATED WITH INCA ROAD DRAINAGE REPAIR, DOUGLAS COUNTY PROJECT NUMBER SP 2020-026.

**WHEREAS,** Douglas County Engineering Division is requesting a temporary road closure for Inca Road between Delaware Drive and Cheyenne Drive. The closure will allow for the emergency repair of a failing existing drainage embankment protector and an icing hazard in Inca Road; and

WHEREAS, Inca Road is a County-maintained roadway; and

**WHEREAS**, the Board of County Commissioners (the "Board") has the authority to temporarily prohibit the operation of vehicles upon roads within its jurisdiction, pursuant to sections 42-4-106(1) and (6), C.R.S.; and

**WHEREAS**, the temporary road closure of Inca Road will be needed for a maximum of approximately 10 days, between on September 15, 2021 and October 6, 2021, when weather allows the completion of the Project on ten consecutive days: and

**WHEREAS**, the Douglas County Engineering Division will prepare a detour - signage plan prior to the closure of Inca Road, now, therefore,

BE IT RESOLVED, by the BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO, hereby authorizes the approval of the temporary road closure of Inca Road between Delaware Drive and Cheyenne Drive for ten (10) consecutive days between September 15, 2021 and October 6, 2021, when weather allows completion of the Project.

**BE IT FURTHER RESOLVED** that a signed detour route, approved warning signs and barricades shall be erected at designated locations, as shown on the attached Exhibit A, prior to the temporary closure authorized herein.

**BE IT FURTHER RESOLVED** that such warning signs and barricades shall be removed, and such road shall be reopened upon expiration of the temporary closure approved herein, or at such earlier time as determined by Douglas County Engineering Division.
