## THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, COLORADO

## RESOLUTION AMENDING RESOLUTION R-018-064 CONCERNING NAMING COUNTY REAL AND PERSONAL PROPERTY AFTER ANY INDIVIDUAL OR ENTITY.

- **WHEREAS**, on July 24, 2018, the Board of County Commissioners adopted Resolution No. R-018-064 concerning the naming of County owned real and personal property after any individual or entity; and
- **WHEREAS**, said Resolution R-018-064, stated that it was the Board's determination that, at that time, it was deemed that County owned properties should not be named for any individual, family, or entity, whether past or current, living or deceased; and
- **WHEREAS**, Colorado counties have the power to purchase and hold real and personal property for the use of the County pursuant to §30-11-101(1)(b), C.R.S.; and
- **WHEREAS**, real or personal property conveyed to a county shall be deemed the property of such county pursuant to §30-11-102, C.R.S; and
- **WHEREAS**, the Board of County Commissioners of the County of Douglas, State of Colorado (the "Board"), pursuant to §30-11-103, C.R.S., is statutorily mandated to exercise the powers of a county as a body politic and corporate; and
- **WHEREAS**, the Board has the authority pursuant to §30-11-107(1)(a), C.R.S., to make such orders regarding property belonging to the County as it deems expedient; and
- **WHEREAS**, the Board, after additional consideration, now deems it appropriate to amend Resolution No. R-018-064, to allow the Board to designate and name certain real and personal property, including buildings and facilities, after individuals that are now deceased but whose contributions to the County have been significant in the determination of the Board; and
- **WHEREAS**, the remaining provisions of Resolution R-018-064, shall remain in full force and effect; now, therefore,
- **BE IT RESOLVED,** BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO, that Resolution R-018-064, is hereby amended to allow the Board to designate and name certain County owned real and personal properties after deceased individuals in order to memorialize the contributions or lives of specific individuals or entities that have contributed to the history of Douglas; and

**BE IT FURTHER RESOLVED**, that the remaining provisions of Resolution R-018-064 shall remain in full force and effect; and
