**THE BOARD OF COUNTY COMMISSIONERS
OF THE COUNTY OF DOUGLAS, COLORADO**

**RESOLUTION SUBDIVIDING MULTIPLE PRECINCTS AS A RESULT OF
INCREASED NUMBERS OF ACTIVE ELIGIBLE ELECTORS IN EXISTING
PRECINCTS AND NEWLY CREATED CONGRESSIONAL AND LEGISLATIVE
DISTRICT BOUNDARIES, IN ACCORDANCE WITH SECTION 1-5-101(3), C.R.S. AND
RESOLUTION R-017-111 AND MODIFYING EXISTING PRECINCT BOUNDARIES
AND ESTABLISHING FORTY-TWO NEW ELECTION PRECINCTS IN
ACCORDANCE WITH SECTION 1-5-103(1), C.R.S.**

WHEREAS, Douglas County has continue to experience significant growth since the current precinct boundaries were created pursuant to R-017-111, and several precincts have exceeded the 2,000 active eligible elector limit; and

WHEREAS, Colorado's Congressional and State Legislative District boundaries have been re-drawn by the Colorado Independent Redistricting Commissions following the 2020 decennial census; and

WHEREAS, new boundaries drawn by the Colorado Independent Redistricting Commissions resulted in three areas that bisected property parcel lines that have been submitted to the Colorado Secretary of State for consideration by the Colorado Supreme Court for correction, and

WHEREAS, Resolution R-006-034 authorizes the County Clerk and Recorder to establish at least one precinct for every two thousand eligible electors; and

WHEREAS, Section 1-5-103(3), C.R.S. permits change in the boundaries of election precincts as well as the creation of new precincts such as those proposed herein;

NOW THEREFORE BE IT RESOLVED, BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO, that multiple precincts be subdivided to create an additional forty-two precincts as depicted on election precinct map attached hereto, is hereby approved, and said election precinct map shall be filed with the office of the Clerk and Recorder of Douglas County; and

BE IT FURTHER RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO that the modified precinct boundary descriptions and the creation of forty-two new precincts as depicted on the precinct map attached hereto, are hereby adopted and approved, resulting in a new total of two-hundred ten (210) precincts.


BE IT FURTHER RESOLVED that this change shall be effective as of January 31, 2022.

BE IT FINALLY RESOLVED that the Clerk and Recorder is authorized by the Board to make further adjustments to the precinct boundaries if and when such changes are authorized or directed by the State of Colorado Supreme Court or Secretary of State to eliminate bisected property parcel lines to ensure individual properties are in only one Congressional or State Legislative District as well as the appropriate corresponding precinct.
