RESOLUTION FOR A TEMPORARY ROAD CLOSURE OF INVERNESS PARKWAY BETWEEN INVERNESS DRIVE WEST AND INVERNESS WAY SOUTH, ASSOCIATED WITH THE INVERNESS / COUNTY LINE SANITARY SEWER REPAIR PROJECT, DOUGLAS COUNTY PROJECT NUMBER DV 2020-373.

WHEREAS, Douglas County Public Works, on behalf of Inverness Water and Sanitation District, is requesting a temporary road closure for Inverness Parkway between Inverness Drive West and Inverness Way South. The closure will allow for the safe and expedited reconstruction of a failing sanitary sewer line within this section of Inverness Parkway; and

WHEREAS, the Board of County Commissioners (the "Board") has the authority to temporarily prohibit the operation of vehicles upon roads within its jurisdiction, pursuant to sections 42-4-106(1) and (6), C.R.S.; and

WHEREAS, the temporary road closure of Inverness Parkway will be needed for a maximum of approximately 35 days, between May 31, 2022, and July 4, 2022, when weather allows the completion of the Project on thirty-five consecutive days: and

WHEREAS, Inverness Water and Sanitation District and their Contractor will prepare a detour - signage plan prior to the closure of Inverness Parkway, generally following the phasing plan shown in Exhibit A, now, therefore,

BE IT RESOLVED, by the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, hereby authorizes the approval of the temporary road closure of Inverness Parkway between Inverness Drive West and Inverness Way South for thirty-five (35) consecutive days between May 31, 2022, and July 4, 2022, when weather allows completion of the Project.

BE IT FURTHER RESOLVED that a signed detour route, approved warning signs and barricades shall be erected at designated locations, as shown on the attached Exhibit A, prior to the temporary closure authorized herein.

BE IT FURTHER RESOLVED that such warning signs and barricades shall be removed and such road shall be reopened upon expiration of the temporary closure approved herein, or at such earlier time as determined by Douglas County Public Works.
