THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, COLORADO

RESOLUTION TO APPROVE A PILOT PROGRAM TO ALLOW THE LIMITED USE OF GRAYWATER IN NEW HOMES WITHIN THE BOUNDARIES OF CANYONS SOUTH PLANNED DEVELOPMENT, AS AMENDED.

WHEREAS The State of Colorado, pursuant to the Colorado Water Quality Control Act (CWQCA) Sections 25-8-101 through 25-8-703, C.R.S., in particular under Section 25-8-205 (1)(g), C.R.S., that allows counties to adopt a resolution approving the use of graywater when used in accordance with federal, state and local requirements; and

WHEREAS, The Board of County Commissioners is authorized, pursuant to Section 30-11-107 (1) (kk), C.R.S., to adopt a resolution approving the use of graywater in compliance with 5 CCR 1002-86 (Colorado Department of Public Health and Environment - Water Quality Control Commission Regulation 86); and

WHEREAS, on July 26, 2022, the Board conducted a public hearing on the adoption of the resolution to allow graywater use under the requirements of the Douglas County Graywater Use Pilot Program regulations and the Douglas County Graywater Design Criteria; and

WHEREAS, the Board desires to allow limited graywater use in compliance with all applicable Federal and State regulations, including 5 CCR 1002-86, only for the purpose of flushing water closet fixtures within a limited number of single family new homes; and

WHEREAS, this greywater use is to be piloted to an area only within the boundaries of the Canyons South Planned Development, as Amended, and which is served by the Castle Rock Water service provider; and

WHEREAS, current Douglas County graywater regulations (attached hereto as Exhibit A) and Douglas County graywater design criteria (attached hereto as Exhibit B), and as they may be amended in the future, are to be implemented as the Douglas County Graywater Use Pilot Program, by the Department of Public Works Engineering -

Building Division and the Douglas County Health Department- Environmental Health; now, therefore,

BE IT RESOLVED, by the Board of County Commissioners of the County of Douglas, State of Colorado, that the Graywater Use Pilot Program to allow the use of graywater only for flushing water closet fixtures in a limited number of new single family homes is approved within the boundaries of Canyons South Planned Development, as Amended, for properties served by Castle Rock Water in accordance with the Douglas County graywater regulations, and as these regulations may be amended in the future.
