

RESOLUTION NO. R-022- 080

THE BOARD OF COUNTY COMMISSIONERS
OF THE COUNTY OF DOUGLAS, COLORADO

RESOLUTION DESCRIBING A PROPOSAL TO RE-ESTABLISH DOUGLAS
COUNTY'S LEGAL AUTHORITY TO PROVIDE ADVANCED SERVICES (HIGH
SPEED INTERNET), CABLE TELEVISION SERVICES, AND/OR
TELECOMMUNICATIONS SERVICES, IN PARTNERING WITH PUBLIC OR
PRIVATE SECTOR PROVIDERS; CALLING AN ELECTION ON NOVEMBER 8, 2022,
FOR THE CONSIDERATION OF SUCH PROPOSAL; AND SETTING THE BALLOT
TITLE AND BALLOT QUESTION FOR THE ELECTION.

WHEREAS, affordable, reliable, and innovation telecommunications services, including, but not limited to, broadband internet services, are hereby found and determined to be essential for Douglas County residents and businesses in today's economic environment, health and safety and for quality of life; and

WHEREAS, in 2005 the Colorado General Assembly enacted Senate Bill 05-152, which is codified at C.R.S. § 29-27-101, *et seq.*, which provides that before a local government may provide telecommunications services, advanced services (high speed internet), or cable television services, as such services are defined in the statute, either directly or indirectly, it must call an election on the question of providing such services and obtain the approval of the majority of its registered electors voting on any such ballot question; and

WHEREAS, the effect of Senate Bill 05-152, as codified in Colorado statute, has been to restrict the county's ability to improve its connectivity through either the provision of direct, or indirect services in cooperation with other public or private sector service providers, as set forth in C.R.S. § 29-27-103, "Limitations on providing cable television, telecommunications, and advanced services"; and

WHEREAS, the Douglas County Board of County Commissioners does hereby find and determine that re-establishing the County's legal ability to assist in the establishment of partnerships to provide such cable television, telecommunications, and advanced services (high speed internet) could allow Douglas County to help implement local telecommunications solutions that would provide or improve needs-based access for the County's residents and businesses; and

WHEREAS, the Douglas County Board of County Commissioners desires to refer to the registered electors of the County a proposal to re-establish the County's legal ability to assist in the establishment of partnerships to provide cable television, telecommunications, and advanced services (high speed internet) either directly or indirectly and with public or private sector service providers at the next general election on November 8, 2022, and such election date is within the next succeeding 120 days after the adoption of this Resolution; and

WHEREAS, pursuant to C.R.S. § 1-5-203(3), C.R.S., the Douglas County Board of County Commissioners must certify ballot contents to the Douglas County Clerk and Recorder for said November 8, 2022, election; and

WHEREAS, any such ballot question must be approved by a majority of the legally eligible Douglas County registered electors voting on such ballot measure before becoming effective;

NOW, THEREFORE, BE IT RESOLVED by the Douglas County Board of County Commissioners that there shall be referred to the registered electors of Douglas County at the general election to be held on November 8, 2022, the following proposal:

The following ballot question and title is hereby certified to the Douglas County Clerk and Recorder for submission to the registered voters of Douglas County, Colorado, at the November 8, 2022, general election:

Without increasing taxes, and pursuant to Title 29, Article 27, Part 1 of the Colorado Revised Statutes, shall Douglas County be authorized to re-establish the authority to participate in, facilitate, or partner with third parties offering advanced services (also known as high speed internet access capability), cable television service and/or telecommunications service, including any new and improved bandwidth services, utilizing the existing County owned fiber optic network and/or developing additional infrastructure, either directly or indirectly to residential, commercial, nonprofit, government or other subscribers within the boundaries of Douglas County, Colorado?

Election Called. It is hereby determined that an election shall be held on November 8, 2022, as part of the general election, for the purpose of submitting to the registered electors of Douglas County the ballot question set forth herein.

Notices of Election. The Douglas County Clerk and Recorder shall publish the text of this Resolution four separate times, a week apart, in the official newspaper of Douglas County.

The Douglas County Clerk and Recorder shall cause to be published, at least twenty (20) days before the election, the notice required by C.R.S. § 1-5-205. Such notice shall be in the form and contain the information required by law. The notice shall also be posted at least ten (10) days before the election as required by C.R.S. § 1-5-203(1.3), C.R.S.

Election Official. The Douglas County Clerk and Recorder is designated as the County's "Designated Election Official" as defined in C.R.S. § 1-1-104(8), as the person responsible for running the election; and shall undertake all measures necessary to comply with and conduct the election in accordance with the applicable provisions of the Colorado Uniform Election Code of 1992 as amended, and any other general election laws of the State of Colorado.

Severability. If any section, paragraph, clause or provision of this Resolution, or the ballot question certified by this Resolution be adjudged to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining sections, paragraphs, clauses, or provisions of this Resolution or said ballot question. It is the intention of the Douglas County Board of County Commissioners that the various parts of this Resolution and ballot question are severable.
