**THE BOARD OF COUNTY COMMISSIONERS
OF THE COUNTY OF DOUGLAS, COLORADO**

**A RESOLUTION APPROVING THE TEMPORARY ROAD CLOSURES OF HAVANA
STREET BETWEEN LINCOLN AVENUE AND MERIDIAN BOULEVARD**

WHEREAS, Douglas County PW Engineering staff is requesting two temporary road closures for Havana Street between Lincoln Avenue and Meridian Boulevard. The first closure will allow for the installation of storm sewer pipe and the second closure will allow for construction of concrete pavement; and

WHEREAS, Havana Street is a County-maintained roadway; and

WHEREAS, the Board of County Commissioners (the "Board") has the authority to temporarily prohibit the operation of vehicles upon roads within its jurisdiction, pursuant to sections 42-4-106(1) and (6), C.R.S.; and

WHEREAS, two temporary road closures of Havana Street between Lincoln Avenue and Meridian Boulevard are needed for one weekend each, defined as Friday at 6:00 PM until Monday at 6:00 AM, with the first closure occurring between the dates of August 26, 2022 and September 5, 2022 with a second closure occurring between the dates of October 14, 2022 and November 14, 2022.

WHEREAS, Douglas County PW Engineering staff has prepared detour and signage plans for the closure of Havana Street; now, therefore,

BE IT RESOLVED, by the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, hereby authorizes the approval of two temporary road closures of Havana Street between Lincoln Avenue and Meridian Boulevard for one weekend each, defined as Friday at 6:00 PM until Monday at 6:00 AM, with the first closure occurring between the dates of August 26, 2022 and September 5, 2022 with a second closure occurring between the dates of October 14, 2022 and November 14, 2022.

BE IT FURTHER RESOLVED that a signed detour route with approved warning signs and barricades shall be erected at designated locations, as shown on the attached Exhibit A, prior to the temporary closure authorized herein.

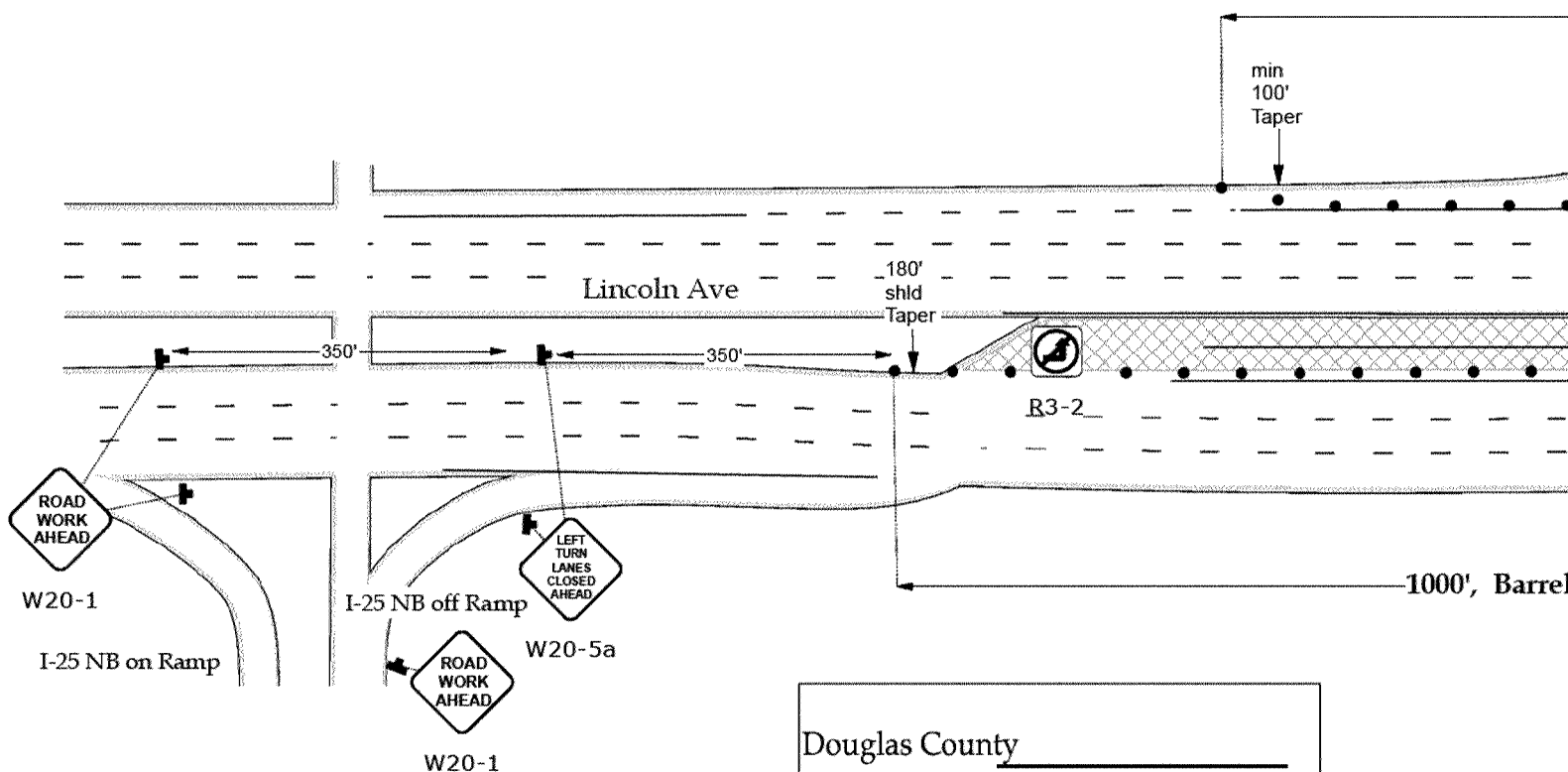
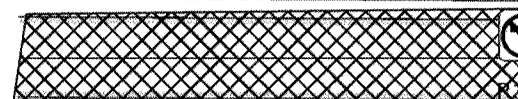
