RESOLUTION APPROVING THE DRAW IN THE AMOUNT OF \$39,704.00 ON IRREVOCABLE LETTER OF CREDIT NO. LC 2326 ISSUED BY TEXAS CAPITOL BANK, N.A. IN CONNECTION WITH ROXBOROUGH DOWNS FILING 2, 5TH AMENDMENT, WARRANTY PERFORMANCE SECURITY. DOUGLAS COUNTY PROJECT NUMBER DV 2016-330.

- **WHEREAS,** on September 11, 2019, Texas Capitol Bank, N.A. issued its Irrevocable Letter of Credit No. LC 2326 ("LOC"), in the amount of \$39,704.00 and
- *WHEREAS*, said Letter of Credit was issued at the request of Cardel Homes U.S., L.P. ("Developer"), as Warranty Performance for Roxborough Downs Filing 2, 5th Amendment, of its obligations under the Subdivision Improvements Agreement ("SIA"), for Project No. DV 2016-286; and
- WHEREAS, said Letter of Credit will expire on March 1, 2022, and, under the terms and conditions of the Subdivision Improvements Agreement for Private Development ("SIA"), security must remain valid and in full force and effect until all required improvements have been completed and inspected by Douglas County; and
- **WHEREAS**, the Douglas County Engineering Division has determined that those obligations of Cardel Homes U.S., L.P. have not been fulfilled; and
- WHEREAS, Cardel Homes U.S., L.P. is in default in the performance of its obligations under the SIA; and
- **WHEREAS**, Cardel Homes U.S., L.P. was provided with a minimum of fourteen days written notice of Douglas County's intention to draw on said Letter of Credit: and
- WHEREAS, Cardel Homes U.S., L.P. was provided timely notice of the hearing on this matter; and
- **WHEREAS**, the Board of County Commissioners has concluded that to maintain its security for the performance of the obligations of Cardel Homes U.S., L.P., under the terms of the SIA, it must draw on said Letter of Credit No. LC 2326, in the amount of \$39,704.00 now, therefore,
- **BE IT RESOLVED** by the Board of County Commissioners of the County of Douglas, State of Colorado, that the Chair or Vice Chair of the Board of County Commissioners is authorized and directed to draw on said Letter of Credit No. LC 2326, issued by Texas Capitol Bank, N.A., in the amount of \$39,704.00, and to execute any statement, draft, or other documents necessary to accomplish said draw on or before September 30, 2022; now, therefore,
- **BE IT FURTHER RESOLVED**, if Cardel Homes U.S., L.P. extends said Letter of Credit to September 30, 2023, before such draw is made, this resolution shall have no further effect and such draw on said Letter of Credit shall not be made.
