## RESOLUTION SUPPLEMENTING THE 2022 ADOPTED BUDGET TO APPROPRIATE UNANTICIPATED GRANT REVENUES AND APPROPRIATE RESTRICTED, ASSIGNED, AND UNASSIGNED FUND BALANCES IN THE AMOUNT OF \$39,093,331.
