**THE BOARD OF COUNTY COMMISSIONERS
OF THE COUNTY OF DOUGLAS, COLORADO**

**RESOLUTION APPROVING THE NAME CHANGE OF THE “UNIFIED
METROPOLITAN FORENSIC CRIME LABORATORY” TO THE UNIFIED
FORENSIC LABORATORY”.**

WHEREAS, on December 20, 2016, the Board of Commissioners of the County of Arapahoe, for and on behalf of the Arapahoe County Sheriff (hereinafter “Arapahoe”), the City of Aurora (“Aurora”), and the Douglas County Board of County Commissioners, for and on behalf of the Douglas County Sheriff (hereinafter “Douglas”)(collectively, the “Parties”), entered into an Inter-governmental Agreement (hereinafter, the “IGA”) to create and form a regional forensic crime laboratory to improve law enforcement services across the involved agencies; and

WHEREAS, pursuant to §29-1-203, C.R.S., the IGA was formed to create a cooperative agreement for the purpose of providing for a regional, multi-jurisdictional forensic crime laboratory (“Crime Lab”) available for use by participating law enforcement agencies on a cost-sharing basis, and

WHEREAS, Section 1 of the IGA provides that the Crime Lab shall be known by a name as mutually agreed upon by the Parties; and

WHEREAS, following execution of the IGA, the Parties mutually agreed upon the “Unified Metropolitan Forensic Crime Laboratory” (“UMFCL”) as the name for the Crime Lab; and

WHEREAS, on January 25, 2023, the governing Board of the laboratory voted to approve a change in the name of the Crime Lab to the “Unified Forensics Laboratory” or “UFL”; and

WHEREAS, in accordance with Section 1 of the IGA, the Parties wish to formally adopt the name change of the Crime Lab as set forth in this Resolution.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
COMMISSIONERS OF THE COUNTY OF DOUGLAS, COLORADO, THAT:**

Section 1. The Board of County Commissioners approves changing the name of the Crime Lab from “Unified Metropolitan Forensic Crime Laboratory” to the “Unified Forensic Laboratory.”

Section 2. All resolutions or parts of resolutions of the County in conflict are expressly repealed.
