**THE BOARD OF COUNTY COMMISSIONERS
OF THE COUNTY OF DOUGLAS, COLORADO**

**A RESOLUTION APPROVING THE TEMPORARY ROAD CLOSURE OF BAYOU
GULCH ROAD BETWEEN PRADERA PARKWAY AND SCOTT AVENUE**

WHEREAS, Douglas County PW Engineering staff is requesting two (2) temporary road closures for Bayou Gulch Road between Pradera Parkway and Scott Avenue. The closures will allow for the for construction of the upcoming Bayou Gulch Road (Pradera Parkway to Scott Avenue) Project, Douglas County Project Number CI 2015-010; and

WHEREAS, Bayou Gulch Road is a County-maintained roadway; and

WHEREAS, the Board of County Commissioners (the "Board") has the authority to temporarily prohibit the operation of vehicles upon roads within its jurisdiction, pursuant to sections 42-4-106(1) and (6), C.R.S.; and

WHEREAS, a temporary road closure of Bayou Gulch Road between Pradera Parkway and Scott Avenue is requested from June 26, 2023 to October 31, 2023 (90 workdays). Additionally, a temporary road closure of Bayou Gulch Road between Vistancia Drive and Scott Avenue is requested from November 1, 2023 to June 15, 2024 (156 workdays). Both closures will be implemented no longer than the duration needed for construction of the Bayou Gulch Road (Pradera Parkway to Scott Avenue) Project, Douglas County Project Number CI 2015-010; and

WHEREAS, Douglas County Engineering staff will review and approve specific detour and signage plans from the construction contractor in accordance with Douglas County standards and specifications; now, therefore,

BE IT RESOLVED, by the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, hereby authorizes the approval of a temporary road closure of Bayou Gulch Road between Pradera Parkway and Scott Avenue from June 26, 2023 to November 15, 2023 (90 workdays) and another temporary road closure of Bayou Gulch Road between Vistancia Drive and Scott Avenue from November 16, 2023 to June 15, 2024 (156 workdays).

BE IT FURTHER RESOLVED that a signed detour route with approved warning signs and barricades shall be erected at designated locations, as approved by Douglas County

staff, prior to the temporary closure authorized herein. The attached Exhibit A shows the proposed road closures and anticipated detour of Bayou Gulch Road to Pradera Parkway and Crowfoot Valley Road.

BE IT FURTHER RESOLVED that such warning signs and barricades shall be removed and such road shall be reopened upon expiration of the temporary closure approved herein, or at such earlier time as determined by PW Engineering staff.



