**RESOLUTION FOR TEMPORARY ROAD CLOSURE FOR INVERNESS DRIVE
SOUTH JUST EAST OF THE INVERNESS WAY SOUTH INTERSECTION,
ASSOCIATED WITH THE INVERNESS DRIVE SOUTH BRIDGE REPAIR PROJECT,
DOUGLAS COUNTY PROJECT NUMBER CI 2020 – 035.**

WHEREAS, Douglas County PW Engineering staff is requesting a temporary road closure for Inverness Drive South just east of the Inverness Way South intersection. The closure will allow for the completion of Inverness Drive South Bridge Repair Project, CI 2020-035; and

WHEREAS, Inverness Drive South is a County owned and maintained roadway; and

WHEREAS, the Board of County Commissioners (the “Board”) has the authority to temporarily prohibit the operation of vehicles upon roads within its jurisdiction, pursuant to sections 42-4-106(1) and (6), C.R.S.; and

WHEREAS, the temporary road closure of Inverness Drive South will be needed for a maximum of 45 days in calendar year 2024, approximately beginning on July 5, 2023 and ending on August 18, 2023; and

WHEREAS, Douglas County PW Engineering staff has prepared detour and signage plans for the closure of Inverness Drive South; now, therefore,

BE IT RESOLVED, by the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, hereby authorizes the approval of the temporary road closure of Inverness Drive South just east of the Inverness Way South intersection for Forty-Five (45) days, approximately between July 5, 2023 and August 18, 2023.

BE IT FURTHER RESOLVED that a signed detour route with approved warning signs and barricades shall be erected at designated locations, as shown on the attached Exhibit A, prior to the temporary closure authorized herein.

BE IT FURTHER RESOLVED that such warning signs and barricades shall be

removed and such road shall be reopened upon expiration of the temporary closure approved herein, or at such earlier time as determined by PW Engineering staff.
