**A RESOLUTION PROCLAIMING A “DOUGNAD” IN DOUGLAS COUNTY TO
COINCIDE WITH NATIONAL VOLUNTEER MONTH IN APRIL AND NATIONAL
VOLUNTEER WEEK, APRIL 21th THROUGH 27th**

WHEREAS, April is National Volunteer Month, and April 21st through April 27th is National Volunteer Week, a time to celebrate and recognize the contributions of volunteers; and

WHEREAS, in Norway, strong social connections are formed through participation in a “dugnad”, which is voluntary work performed in as part of a community social gathering; and

WHEREAS, in the spirit of this Norwegian tradition, Douglas County announces its spring “Dognad” to promote and encourage volunteerism throughout the County; and

WHEREAS, Throughout the month of April, Douglas County residents can participate in volunteer events in their community, including a Spring Cleanup Day on April 6th in Castle Pines; a Superhero Extravaganza event on April 12th in Parker; County-sponsored tree-planting and clean up events on April 19th, 22nd, and 26th; clean up, trail maintenance and Earth Day events in Castle Rock on April 4th, 6th, 7th, 13th, 19th, 20th, and 26th; a Renew the Ranch clean up event on April 20th and an Arbor Day event on April 26th in Highlands Ranch; and the County’s Dognad event at Highland Heritage Regional Park on the morning of April 20th; and

WHEREAS, many more opportunities for volunteering are available through civic and faith-based organizations and Douglas County will soon begin planning for a fall Dognad event in partnership with these organizations; and

NOW, THEREFORE, BE IT RESOLVED THAT THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, COLORADO, proclaims a Dognad in Douglas County as a celebration of volunteerism, to be celebrated during National Volunteer Month this April and National Volunteer Week April 21st through April 27th.
