**RESOLUTION FOR THE TEMPORARY ROAD CLOSURE OF HAPPY CANYON
ROAD FOR THE BMW CHAMPIONSHIP – DOUGLAS COUNTY PROJECT NUMBER
DV 2024-194.**

WHEREAS, Douglas County PW Engineering staff is requesting an 8 calendar day temporary road closure for Happy Canyon Road between Castle Pines Drive North and Castle Pines Drive South. The closure will allow for the effective management of vehicular traffic during the 2024 BMW Championship; and

WHEREAS, Happy Canyon Road is a County-maintained roadway; and

WHEREAS, the Board of County Commissioners (the “Board”) has the authority to temporarily prohibit the operation of vehicles upon roads within its jurisdiction, pursuant to sections 42-4-106(6), C.R.S.; and

WHEREAS, the temporary road closure of Happy Canyon Road will be needed for a maximum of 7 calendar days, during the times of 6 AM – 7 PM daily, to occur between August 19, 2024 and ending on August 25, 2024; and

WHEREAS, Douglas County PW Engineering staff will work with the Western Golf Association to prepare detour and signage plans for the closure of Happy Canyon Road; now, therefore,

BE IT RESOLVED, by the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, hereby authorizes the approval of the temporary road closure of Happy Canyon Road between Castle Pines Drive North and Castle Pines Drive South for 8 calendar days between August 19, 2024, and August 25, 2024.

BE IT FURTHER RESOLVED that a signed detour route with approved warning signs and barricades shall be erected at designated locations, as agreed upon by Douglas County PW staff and the Western Golf Association, prior to the temporary closure authorized herein.

BE IT FURTHER RESOLVED that such warning signs and barricades shall be removed, and such road shall be reopened at 7 PM daily during the closure and upon expiration of the temporary closure approved herein, or at such earlier time as determined by PW Engineering staff.
