

**RESOLUTION NO. R-024-087**

**Resolution for a Temporary Road Closure of Irish Pat Murphy Drive between Thunder Hill Road and South Pinery Parkway, associated with Pinery Water and Wastewater's Irish Pat Murphy Drive Water Line Replacement Project, Douglas County Project Number DV 2024-081.**

**WHEREAS**, Pinery Water and Wastewater is requesting a temporary road closure for Irish Pat Murphy Drive between Thunder Hill Road and South Pinery Parkway. The closure will allow for the replacement of a water line in Irish Pat Murphy Drive by Pinery Water and Wastewater; and

**WHEREAS**, the Board of County Commissioners (the "Board") has the authority to temporarily prohibit the operation of vehicles upon roads within its jurisdiction, pursuant to sections 42-4-106(1) and (6), C.R.S.; and

**WHEREAS**, the temporary road closure of Irish Pat Murphy Drive will be needed for a maximum of approximately 140 days, between August 14, 2024 and December 31, 2024, in multiple phases, limiting the length of closure of each phase to a maximum of 250 feet for any single phase, when weather allows the completion of the Project in one hundred forty consecutive days; and

**WHEREAS**, Pinery Water and Wastewater will prepare a detour – signage plan prior to the closure of Irish Pat Murphy Drive, generally following the typical phasing plan shown in Exhibit A, now, therefore,

**BE IT RESOLVED**, by the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, hereby authorizes the approval of the temporary road closure of Irish Pat Murphy Drive between Thunder Hill Road and South Pinery Parkway for one hundred forty (140) consecutive days between August 14, 2024, and December 31, 2024, when weather allows completion of the Project.

**BE IT FURTHER RESOLOVED** that a typical signed detour route, approved warning signs and barricades shall be erected at designated locations, as shown on the attached Exhibit A, prior to the temporary closure authorized herein.


