**A RESOLUTION ADOPTING FEE SCHEDULES FOR THE DOUGLAS

RECORDS-FEES AUTHORIZED**

WHEREAS, the Douglas County Sheriff's Office has requested that the Board of County Commissioners ("Board") adopt a revised fee schedule in order to collect fees for certain services performed by the Douglas County Sheriff's Office ("Sheriff's Office"); and

WHEREAS, pursuant to section 30-1-104, C.R.S., Fees for Sheriff, section 18-1.3-106(4), C.R.S., Work Release Fees, and 24-72-306, C.R.S., Copies, Printouts, or Photographs of Criminal Justice Records-Fees Authorized, the Sheriff's Office is authorized to collect fees for the performance of certain services; and

WHEREAS, the Sheriff's Office has recommended that the Board adopt the fee schedules in the forms attached hereto as Exhibits A, B, C and D; now, therefore,

BE IT RESOLVED, BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO, AS FOLLOWS:


The fee schedules for those services provided by the Sheriff's Office, in the form attached hereto as Exhibits A, B, C and D, are hereby approved; and


FURTHER RESOLVED, that the fee schedules adopted herein shall become effective as of September 24, 2024, and any prior adopted fee schedules for the Douglas County Sheriff's Office are hereby repealed by the adoption of this resolution.

- (h.5) Mileage for the service of a writ, subpoena or other process in other than a criminal action will be charged at the mileage rate authorized for County officials and employees pursuant to C.R.S. 30-11-107(1) (t), as amended and Douglas County Travel Policy III 6.2, as revised. The Sheriff's Office will post the current rate in a location accessible to the public pursuant to C.R.S. 30-1-108, as amended.

The Douglas County Sheriff's Office may establish a zone or zip code-based mileage fee structure. The zone or zip code-based mileage fee structure shall establish a single mileage fee for the service of any writ, subpoena or other process in an action, other than a criminal action, in each separate zone or zip code, as applicable, in Douglas County. The applicable single mileage fee shall be charged for all papers served in the zone or zip code regardless of the number of attempts or actual mileage traveled by a Sheriff. The Douglas County Sheriff's Office has established a zone or zip code-based mileage fee structure as set forth in Exhibit "C" and are hereby set by resolution and approved by the Board of County Commissioners. The Sheriff's Office will post Exhibit "C" in a location accessible to the public pursuant to C.R.S. 30-1-108, as amended.

Pursuant to C.R.S. 30-1-105.5, as amended, in situations when two or more papers are served on the same person or different persons at the same time and place and in the same action, the Sheriff shall charge the highest individual fee allowable pursuant to C.R.S. 30-1-104, as amended, for the first process and an additional ten dollars (\$10.00) for each subsequent process served. The Sheriff shall charge the single zone or zip code-based/mileage-based fee for the first process.

All research fees and/or redaction fees will be estimated and collected before the research or redaction starts. If the citizen refuses to pay in advance, the records/videos/audio documents/discs will not be provided.

Cost per ID for radios programmed by another agency that require a Douglas County radio ID. This cost covers the radio system ID management, building the system level radio and user alias files, and alias maintenance for the life of the radio.	\$ 35.00
Cost per radio for reprogramming and realignment if the reprogramming is not system driven. This rate also applies to the labor cost for minor repairs of the radio such as basic troubleshooting, knobs, switches, seals, displays, and reprogramming due to corrupt code plugs. The cost of the parts and materials used to make the repairs will be billed in addition to the labor charge. This does not include Motorola service shop, depot, or board level repairs.	\$ 35.00
Any other services for technical advisement or systems repairs in lieu of maintenance contracts will be billed at the rate of \$90 per hour. Time is billed from the time of response and trip completion, not the time of onsite arrival and departure.
