

**RESOLUTION NO. R-024- 106**

**THE BOARD OF COUNTY COMMISSIONERS  
OF THE COUNTY OF DOUGLAS, COLORADO**

**A RESOLUTION APPROVING THE DRAW IN THE AMOUNT OF \$41,338.00 ON  
IRREVOCABLE LETTER OF CREDIT NO. HACH699584OS ISSUED BY BMO BANK, N.A. IN  
CONNECTION WITH STONE CREEK RANCH FILING 1, VILLAGE A, PHASE 1, EAST OFF-  
SITE PERFORMANCE, EXECUTED BY KB HOME COLORADO, INC.,**

***WHEREAS***, on September 16, 2019, BMO Bank, N.A., issued its Irrevocable Letter of Credit No. HACH699584OS (“LOC”), as amended, in the amount of \$41,338.00; and

***WHEREAS***, said Letter of Credit was issued at the request of KB Home Colorado, Inc. (“Developer”), as Warranty Performance, of its obligations under the Subdivision Improvements Agreement (“SIA”), for Project No. DV2014-380; and

***WHEREAS***, said Letter of Credit will expire on October 1, 2024, and, under the terms and conditions of the Subdivision Improvements Agreement (“SIA”), security must remain valid and in full force and effect until all required improvements have been completed and inspected by Douglas County; and

***WHEREAS***, the Douglas County Engineering Division has determined that those obligations of KB Home Colorado, Inc. have not been fulfilled; and

***WHEREAS***, KB Home Colorado, Inc. is in default in the performance of its obligations under the SIA; and

***WHEREAS***, KB Home Colorado, Inc. was provided with a minimum of fourteen days written notice of Douglas County’s intention to draw on said Letter of Credit: and

***WHEREAS***, KB Home Colorado, Inc. was provided timely notice of the hearing on this matter; and

***WHEREAS***, the Board of County Commissioners has concluded that in order to maintain its security for the performance of the obligations of KB Home Colorado, Inc., under the terms of the SIA, it must draw on said Letter of Credit No. HACH699584OS, in the amount of \$41,338.00 now, therefore,


**BE IT RESOLVED** by the Board of County Commissioners of the County of Douglas, State of Colorado, that the Chair or Vice Chair of the Board of County Commissioners is authorized and directed to draw on said Letter of Credit No. HACH699584OS, issued by BMO Bank, N.A., in the amount of \$41,338.00, and to execute any statement, draft, or other documents necessary to accomplish said draw on or before October 1, 2024; now, therefore,

**BE IT FURTHER RESOLVED**, if KB Home Colorado, Inc. extends said Letter of Credit to October 1, 2025, before such draw is made, this resolution shall have no further effect and such draw on said Letter of Credit shall not be made.


