

**RESOLUTION NO. R-024- 123**

**THE BOARD OF COUNTY COMMISSIONERS  
OF THE COUNTY OF DOUGLAS, COLORADO**

**A RESOLUTION APPROVING THE TEMPORARY ROAD CLOSURES OF COUNTY  
LINE ROAD BETWEEN UNIVERSITY BOULEVARD AND BROADWAY**

**WHEREAS**, Douglas County PW Engineering staff is requesting two temporary road closures for County Line Road between University Boulevard and Broadway for the upcoming capital improvement project to widen and reconstruct County Line Road, Douglas County Project Number CI 2020-013; and

**WHEREAS**, the first closure will allow for the installation of embankment material and water line relocation, and the second closure will allow for construction and installation of storm sewer pipe; and

**WHEREAS**, County Line Road is a County-maintained roadway; and

**WHEREAS**, the Board of County Commissioners (the “Board”) has the authority to temporarily prohibit the operation of vehicles upon roads within its jurisdiction, pursuant to sections 42-4-106(1) and (6), C.R.S.; and

**WHEREAS**, the first closure shall not exceed 100 days and will take place between June 1, 2025 and March 30, 2026, depending on the project phasing and contractor’s approved construction schedule; and

**WHEREAS**, the first closure will be from the east side of S Clarkson Street to the west side of the 1700 E County Line Road business access; and

**WHEREAS**, during the first closure, access to S Clarkson Street and all businesses will remain open throughout the duration of this closure; and

**WHEREAS**, the second closure will take place between June 1, 2025 and October 31, 2026 and will be for three storm sewer crossings for a maximum of 72 hours each between E Philips Avenue and 1900 E County Line Road, which serves as the primary access to the Target department store; and

**WHEREAS**, Douglas County PW Engineering staff will review and approve detour and signage plans for the closures of County Line Road; now, therefore,

**BE IT RESOLVED**, by the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, hereby authorizes the approval of two temporary road closures of County Line Road between University Boulevard and Broadway for the widening and reconstruction of County Line Road, Douglas County Project Number 2020-013.

**BE IT FURTHER RESOLVED** that the first closure shall not exceed 100 days, and will take place between June 1, 2025 and March 30, 2026 from the east side of S Clarkson Street to the west side of the 1700 E County Line Road business access.


**BE IT FURTHER RESOLVED** that the second closure will take place between June 1, 2025 and October 31, 2026 and will be for three separate storm sewer crossings for a maximum of 72 hours each between E Philips Avenue and 1900 E County Line Road.


**BE IT FURTHER RESOLVED** that a signed detour route with approved warning signs and barricades shall be erected at designated locations, prior to the temporary closure authorized herein.

**BE IT FURTHER RESOLVED** that such warning signs and barricades shall be removed and such road shall be reopened upon expiration of the temporary closure approved herein, or at such earlier time as determined by PW Engineering staff.
