**THE BOARD OF COUNTY COMMISSIONERS

**A RESOLUTION AMENDING RESOLUTION NOS. R-994-099, R-995-099 AND R-995-100
TO DECREASE THE VENDOR'S FEE ALLOWED TO BE RETAINED EFFECTIVE
JULY 1, 2025**

WHEREAS, pursuant to Resolution No. R-994-099 ("open Space Sales Tax Resolution"), R-995-099 ("Justice Center Sales Tax Resolution"), and R-995-100 ("County Roads Sales Tax Resolution") (collectively "Sales and Use Tax Resolutions") Douglas County has implemented the collection of sales and use tax for purposes related to the adopting of said Sales and Use Tax Resolutions; and

WHEREAS, the provisions of paragraph 13 of each of the Sales and Use Tax Resolutions, provide that every retailer shall be entitled to withhold a vendor's fee in the amount of three and one-third percent of the monthly sales tax remitted to cover the retailer's expenses in the collection and remittance of said taxes; and

WHEREAS, the Sales and Use Tax Resolutions each provide that subsequent to their adoption, certain provisions including the vendor fee provision may be amended by a majority vote of the Board of County Commissioners (the "Board"); and

WHEREAS, the Board desires to amend the Sales and Use Tax Resolutions and modify paragraph 13 the "Vendor Fee" paragraph of each of the Sales and Use Tax Resolutions and reduce the vendor fee; now, therefore

BE IT RESOLVED, BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO, that the monthly vendor's fee, provided for by the Sales and Use Tax Resolutions, shall be amended by deleting paragraph 13 of Resolution Nos. R-994-099, R-995-099 and R-995-100 in their entirety and replacing each paragraph 13 with the following:

"13. Vendor's Fee: Pursuant to SB24-025 which sets forth any statutory local government, special district, or requesting home rule jurisdiction shall not impose any kind of limitation on the amount of sales or use tax that a vendor may retain, the two and one-third percent vendor fee is reduced to 1.72 percent effective July 1, 2025."
